Director of IT, Larry Locke stated that he called the company to get a price on the same camera and was told they no longer make that model. He stated that the camera they are requesting to purchase is not compatible with the current DVR system. He stated he would like the board to authorize spending up to \$3,200 to purchase a replacement MAST Camera with DVR and infrared capabilities for the Command Trailer. Paul Perryman made a motion to approve purchasing a replacement MAST Camera with DVR and infrared capabilities for the Command Trailer for a cost up to \$3,200.00; 2nd by Leroy Biggers; motion carried 4-0.
