1. CALL TO ORDER

5. CONSENT AGENDA

Leroy Biggers made a motion to approve the (a.) minutes of the August 22, 2016 Regular Meeting, September 12, 2016 1st Public Hearing, September 12, 2016 Called Meeting, September 19, 2016 2nd Public Hearing, September 19, 2016 Called Meeting, and September 19, 2016 Committee Meeting as written; (b.) the August 2016 financial report; 2nd by Charles Wilson; motion carried 4-0.

6. PAYMENTS AND REIMBURSEMENTS

Charles Wilson made a motion to approve payment of bills: (a.) VFD Reimbursements – 4 August Packets \$2,627.62, 7 VFDs no Reimbursable Expenses; (b.) Current bills/quotes over \$2,000: Gear Cleaning Solutions \$4,621.78 – District Bunker Gear – Inspection, Repairs, & Cleaning; 2nd by Matt Thiessen; motion carried 4-0. Contract payments made – no action necessary: Mobile Communications \$2,738.25 – District Paging Services; Nextiva \$2,005.62 - District Phones & Fax; TML \$6,464.48 – Employee Medical Insurance; Smith Co. Appraisal District \$17,578-Quarterly Appraisal District Fees;

7. ADOPT THE 2016 TAX RATE OF 0.084648 PER \$100 TAXABLE VALUE

President Melton stated that SCESD2 has had the required public hearings pertaining to setting the tax rate and the increase in the tax revenue; it is time to entertain a motion to adopt the 2016 tax rate. Matt Thiessen made a motion to adopt the 2016 Tax Rate of 0.084648 per \$100 taxable value; 2nd by Leroy Biggers; motion carried 4-0. (Resolution 2016-003)

8. FUNDING FOR PURCHASE OF 2016 CHEVROLET 2500HD SILVERADO CREW CAB

President Melton stated that the board approved buying a new command vehicle for Whitehouse VFD in the September 19, 2016 Called Meeting, but failed to stipulate where the funds would be taken from. Matt Thiessen made a motion to amend the 2015/2016 budget to move \$33,554 from the operating account carry-over funds to the 2015/2016 53000 Capital Purchases to pay for the 2016 Chevrolet 2500HD Crew Cab Command Vehicle approved for Whitehouse VFD; 2nd by; Leroy Biggers; motion carried 4-0.

9. DIRECTOR OF FINANCE REPORT

Director of Finance, Denna Mangold, stated that she has received the last check on the Workers' Comp Cost Share Grants, which makes 100% participation for the 3rd year in a row. She also stated

that for the VFDs that voted to have Access Control installed in their stations and pay for it she has the invoices and needs to have the checks in by the end of September; this was for the 2015/2016 budget year. If any VFD has bills or invoices for September, they need to be sent in as soon as possible due to it being the end of the month and the end of the fiscal year. If the VFDs need equipment or supplies they need to let the Battalion Chiefs know and SCESD2 will try to purchase them before the end of this fiscal year.
